- **Financial:** Fr. Simon paid tribute to our two Treasurers, Mark Lindo and Diane Le Grys, who have both worked very hard to keep our finances on a sound footing.
- Diocesan Synod: No report this year; DS has been rather "in abeyance".
- **Other reports:** Fr. Simon welcomed Frank Hartkopf to his first APCM as our licensed Reader. He then thanked all those who had written reports and said that he wished to register his thanks to all the people involved in the work of all four churches, visible or invisible by name in these reports.
- Lunch Club is a very valuable area of Ministry
- **Ladies Guild:** Fr. Simon said that he is dealing with the query about the funds left in the account after the death of Yvonne Gray; there has been a hold-up with the paperwork-death certificates have to be sent both of Yvonne and of Marilyn Endacott, the other signatory; he is negotiating with the executors of both estates, and apologised for the delay in clarification.

## Vicar's Report of the Year

## Background

The PCCs of the parishes of Bickleigh and Shaugh Prior which comprise the **Roborough Team Ministry** have the responsibility of co-operating with the Priest-in Charge, the Revd Simon Rundell in promoting in the ecclesiastical parish the whole mission of the Church: pastoral, evangelistic, social and ecumenical. It also has the responsibility for the maintenance of the Grade I listed Church buildings of S. Mary the Virgin, Bickleigh, S. Edward, King & Martyr, Shaugh Prior, including their respective Churchyards and the unlisted Church of S. Anne in Glenholt. The Parish also has a duty of care to the community which *usually* meets in the Church of England VA School, *Bickleigh Down Primary School* as the Church of S. Cecilia.

## JOINT PCC

The Two PCCs continue to meet in a single meeting. Matters of common interest are discussed jointly. Matters of finance or fabric are voted on by the separate PCCs according to need. This has proved effective in improving the connection between both legal parishes.

Both Parochial Church Councils (PCCs) continue to be charities excepted from registration with the Charity Commission. As their individual incomes (receipts) do not exceed  $\pounds 100,000$ . Each PCC has produced its own Financial Statement.

For the purposes of charity law the Council of PCC members is also the Board of Trustees of the charity.

## **Review of the Year**

This is the ninth full year of Fr. Simon's incumbency in the Roborough Team Ministry. It has been remained a year of huge challenge as a result of the COVID-19 Pandemic and especially the closure of the church buildings for public worship and its transfer online.

## The Life of the Parish

As noted in the previous Annual Report, the enforced closure of church buildings at Lent 4 2020 dramatically changed the pattern of worship and pastoral care, not least because Fr Simon was in a more vulnerable category because of underlying health issues along with a substantial number of members of the Parish.

Worship therefore had to transfer online into an unknown and largely unexplored territory.

It was not a perfect solution, as we recognise that many are excluded from digital access by technology, income or understanding, but significant numbers of the parish have engaged over social media and others in 'digital poverty' have accessed the Parish through telephone conversations, the broadcasting of our worship over the phone or by accessing services offered by the Church of England or the BBC.

Morning and Evening Prayer was broadcast daily throughout lockdown and afterwards, with words displayed on screen so users could join in, or simply reflect on the daily prayer.

The Eucharist continued to be offered, initially from the Vicar's Study (currently resembling a TV studio) and from Sundays in July 2020 from the Churches without congregation. This has enabled the liturgical and spiritual life of the Churches to be continued in these difficult circumstances.

In September 2020 the PCC authorised the recommencement of a Said (Low) Mass across each of the three available Churches (S. Cecilia is currently in use by the school and therefore cannot be made COV-safe). Christmas Services were in both Digital and Analogue form, with an especially well received online service of Nine Lessons and Carols and a Christingle. In December 2020, the nation was locked down again, and the PCC voted to return to online only worship. At Palm Sunday 2021 the Church returned once more, but offering a hybrid of worship offered in both in-person and digital at the same time, although singing in Church is not yet permitted. This once more requires a rethinking of how best to present it in as cost-effective a solution as possible and some further bumps on the road should be expected. We do not have the resources of many churches to build these facilities permanently into the Churches, but for a moderate cost, and the application of some technical knowhow, this has been effected. The impact of all this on Church numbers, on the spiritual and worshipping life of the Parishes and our engagement with our local communities remains to be seen.

**Bickleigh Down School** remains locked into year-group bubbles, and so Fr Simon continues to deliver weekly videoed collective worship for use in classrooms (as the pupils cannot gather collectively). Many of these have been made available to members of the Parish through the weekly email newsletter on YouTube. They are very well received.

The Foundation Governors have continued to ensure the quality of education at the school, and following the retirement of Martin Hancock, we have been seeking to appoint a new Headteacher to take the school forward, maintaining its Church School Distinctiveness and close association with the Parish.

Fr Simon has been in Ministry for 20 years now, and he is still due a Sabbatical. Fr Simon's planned Sabbatical from August 2021 has been deferred until 2022 at the earliest.

### Summary

The Annual Report for 2020 is a strange beast, not least because it features a less than complete year undertaken in interesting times. We must hold the faith and look forward to resurrection which comes each Easter and is a feature of church life, as we emerge from the tomb of Coronavirus.

## **Financial Reports**

## Bickleigh PCC Treasurer's report and Common Fund commentary 2020

### General

Well that was a challenging year and the start of 2021 looks like more of the same! A massive thank you to all of the generous givers who have maintained their support during a huge period of change for all of us.

I can report that even after cancelling virtually all fundraising events and we have still been able to contribute a little to third party collections, this year totalling £206. We have been most fortunate that we haven't had major Church Building repairs in 2020 but we are storing up problems for the future as more ongoing maintenance is needed, particularly the roof, ceilings, organ and clock at St Mary's and the floor and WC at St Anne's. Gift Aid Claims made during the year have assisted our position and the most recent claim has generated £4,480 in 2021 which has been partially used to lessen our common fund shortfall for 2020, as detailed in the notes and below.

### Pandemic - Financial Impact and our response

This continues to have a substantial effect as traditionally only 16% of our income came from regular standing order income, not dependent on Churches being open. We understand that many parishioners will have suffered changing financial circumstances however we have lost large elements of plate and envelope giving, weddings, baptisms, Friends of St Marys fund raising, funerals, St Anne's Hall rentals, community markets etc. Many of our parishioners are, understandably, isolating for their own safety and this did not change much during the summer when lockdown rules were eased.

In income terms we only generated around 60% of last years' total -  $\pounds$ 51,238 2019 and  $\pounds$ 30,635 in 2020 a drop of  $\pounds$ 20,603. This is a massive reduction.

The net result of this was that after a good period to March 2020 we had generated a decent surplus of over  $\pounds 11,000$ , however the remainder of 2020 reduced this to a final cumulative outcome of  $\pounds 8,391$  surplus demonstrating a consistent erosion and deficit of income over expenditure since lockdown started.

To exacerbate this position, we incurred additional pandemic related costs, mainly IT and PPE related, essential expenditure to ensure we offer the fullest online presence possible. The start of 2021 is equally disappointing and does not give us the boost we normally see and need resulting from the Christmas period. People simply have not given as generously for online services as they do for physical services, nor does everyone have access to online technology.

We need to try to improve this as we have again a significant shortfall in our Common Fund payments.

We have taken various actions to restore donations but more still needs to be done:

- Setting up on line giving function on our website giving page with regular reference to this at services and news sheets.
- Information and appeals to parishioners on website and weekly parish news sheets.
- Mailshot to all envelope givers with focus on those not online with reminder they can pay by standing order, providing forms and guidance for this.

The initial response was good with several generous envelope givers sending cheques to catch up missed weeks, albeit this has now tailed off a little and we need to send reminders. We hope that weddings, baptisms etc postponed from 2020 can take place in 2021 and that the St Anne's income from groups, rentals etc. can be quickly restored. At the start of 2021 with the pandemic impact continuing longer than expected, we are starting a fundraising and giving committee to look at ideas and financial stewardship, more details to follow.

We have managed to retain resources within our margin of safety policy (highlighted at last APCM at MIN  $\pm 16k$ ) and at the end of 2020 was standing at  $\pm 22,537$ , albeit we will have various commitments and maintenance/repairs and common fund as detailed in this report to pay from this.

### Common fund 2020

The Diocese assessment for us in 2020 was £29,852.

We had forecast (pre-pandemic) to pay around £20,000 in 2020 (67%) but paid £4,976 (paid July 20) with a further £4,000 paid in February 2021 towards 2020 assessment. This total of £8,976 equates to 30% of our obligations for 2020, not ideal but an increase on last year £5,000) and given the circumstances is a step in the right direction. The Diocese currently appear accepting of this position as we are of course not alone in our struggles at present. We do however need to improve our contribution levels.

### Summary

We can all see the detrimental impact the pandemic has had on our finances. It has shone an uncomfortable light on the mix of our income and how this is worse for a parish such as ours which has relied on income from baptisms, weddings, fund raising and St Anne's hall income to make up the deficit in regular giving receipts. We had all of course hoped to see these activities outside of regular church services restored by now but we hope that we can all see a light at the end of the tunnel with the vaccine programme etc.

We have to look forward with optimism but we will all be asked to consider our contributions and whether we can manage increases, we make no apology for this to keep our wonderful Parish funded and together. Please visit our website to review the giving options. With the continued forbearance of the Diocese on our common fund shortfall together with our estimates for 2021 and our reserves for we believe we can be reassured about the financial stability of the parish, but things do need to change.

### I am most grateful for the generosity of all of our parishioners during these difficult times.

#### Bickleigh Parochial Church Council NOTES TO THE ACCOUNTS FOR THE YEAR ENDED 31ST DECEMBER 2020

#### 1. Accounting policies

The financial statements have been prepared using the Receipts and Payments basis available to small charities and the Church of England guidance.

#### 2.Fund accounting

Unrestricted funds may be used by the PCC for any of its ordinary purposes. Designated funds represent unrestricted funds set aside by the PCC for specific designated purposes; they can be transferred back into general funds at the PCC's decision. Restricted funds represent income which may be expended only on those restricted objects provided in the terms of a trust or bequest, or donations or grants received or invited for a specific purpose. These funds can only be spent on the specific purpose for which they were given. Any balance remaining unspent must be carried forward as a balance on that fund for future expenditure on that specific purpose, or returned; it cannot be absorbed into general funds.

#### 3. Assets used for church purposes

The trustees of the church buildings and contents are the Diocese of Exeter who hold them on trust for the purposes connected with Bickleigh PCC. For insurance purposes

the two church buildings and contents are insured for £11,590,00.00

C. The youth work fund has historically been classified as a restricted fund. The trustees have investigated the sources of the fund and this comprised two separate funds, one to engage a Youth Worker and one to build a Sunday School annex. Neither of these schemes came to fruition. In addition the sources of the funds are partly designated and partly restricted. Following continuing investigation by the trustees further designated funds have been identified and have been transferred. The restricted classification has been retained for the balance; the trustees have completed their investigation and Diocese advice is that use of these funds needs to have clear Youth element.

#### 6. Trustees

The trustees of Bickleigh PCC assets, other than buildings, are the Church Officers and PCC members elected by the Annual Church Meeting. During the year ended 31st December 2020 £2291 was reimbursed to one trustee for expenditure properly incurred on behalf of the PCC.

### St Edwards PCC Financial Statements for the year ended 31 December 2020

#### Aim and purposes

The Parochial Church Council (PCC) has the responsibility of cooperating with the Priest in Charge, the Revd Simon Rundell, in promoting in the parish, the whole mission of the Church, pastoral, evangelistic, social and ecumenical.

The PCC is also specifically responsible for the maintenance of the Churches and church halls.

#### **Objectives and Activities**

The PCC is committed to enabling as many people as possible to worship at our church and to become part of our parish community. The PCC maintains an overview of worship throughout the parish and makes suggestions on how services can involve the many groups that live within the parish. The services and worship put faith into practice through prayer and scripture, music and sacrament. The primary objective of the PCC is the promotion of the Christian Gospel according to the doctrines and practices of the Church of England. In accordance with the PCC (Powers) Measure the PCC has the responsibility of cooperation with the Vicar in promoting within the Parish the whole mission of the Church, pastoral, evangelistic, social and ecumenical.

We try to enable ordinary people to live out their faith as part of our parish community through:

- Worship and prayer; learning about the Gospel; and developing their knowledge and trust in Jesus.
- Provision of pastoral care for people living in the parish.
- Outreach work.

To facilitate this work it is important that the fabric of the Churches and Churchyard is maintained.

#### Structure, governance and management

The Parochial Church Council is a corporate body established by the Church of England. The PCC operates under the Parochial Church Council Powers Measure.

#### **Financial Review**

It has been a difficult year due to the Coronavirus Pandemic with income down due to the church being closed and worship online. No weddings, few funerals and the usually well supported services i.e. Carol Service, Harvest did not happen. Since the re-opening of our church, we have had a reduction in our congregation with regulars not returning. We do have two weddings booked for this year and hopefully will be able to do some much needed fund raising once further restrictions are lifted.

The total receipts on unrestricted funds amounted to £4601 and are detailed in the financial Statement's, restricted income amounted to £1258, designated funds income amounted to £378. Total income £6237 down by £2997 on last year

Total unrestricted expenditure was £7593 showing a deficit of £2992 of expenditure over income at 31 December 2020. Our Common Fund was paid in full.

The churchyard accounts have  $\pm 24$  in as at 31 December 2020 meaning that even if we receive a grant from the Parish Council ( $\pm 400$ ) we will be unable to maintain the cutting of the grass to its usual standard this year. Significant works were undertaken on the bells at a cost of  $\pm 9031$ .

## S. Mary, Bickleigh

This has been a difficult year for our communities with the continuation of the lockdown which we now are starting to see the light as it steadily is lifted. Father Simon has with the support of Father Michael, Frank Hartkopf and all the volunteers who provided readings and intersessions has ensured that the church has been able to provide support to our communities through the online services. As the church is reopened and as the lockdown lifts if anyone who would like to take a Service, they would be most welcome. Volunteers for Side persons, church cleaning, flower arranging, post-service teas and coffees (when permitted), silver cleaning etc. are always needed – no experience necessary. We both would like to pass on our considerable thanks to the small band who unfailingly turn up to assist at all events, but more hands are always desirable and can lighten the workload considerably.

I have not had the opportunity to review the condition of the building of St Mary's Church, but I am sure that I will be made aware of any issues. The boiler will need to be serviced again this year to ensure that it continues to work in the late autumn and winter. A contract still needs to be agreed for the boiler to be serviced annually and that the contract includes emergency call outs for breakdowns.

On a personal note, I Andy have been diagnosed with stage three bowel cancer there are only four stages, I have commenced treatment having had a course of pre-surgical radiotherapy and I am due to commence a three-month course of chemotherapy to try and reduce the size of the tumour so I hope soon after I have completed the chemotherapy it will hopefully be followed by the surgery to remove the tumour. I hope you all can understand that at this time the treatment is having a toll on me so please forgive if I am tardy in my role of Churchwarden as well as my lack of attendance at church at present as these treatments do affect the immune system and I must be careful. I look forward to seeing you all again in church once my treatment is completed.

## S. Edward, Shaugh Prior

The current general condition of the fabric of the Church is reasonable taking into account how little used it has been over the past 12 months. Notwithstanding another wet winter which has resulted in regular water ingress both on the floor of the Tower, the rear of the church and areas in front of the Altar and side chapel, remedial flood defences have been mobilised and the damage kept to a minimum.

The dampness of the South wall (adjacent to the Tower) persists. Furthermore, following heavy rain, water has been accumulating and running down the glass partition at the rear of the church. However, following a recent excursion to the top of the Tower, the main drainage gulley which was suffering from a build-up of moss, leaves and other detritus has been cleared and this has made a very noticeable improvement. There is still further work to do, to keep the gutters and gullies free from debris/leaves/birds nesting. The common problem we have is that much of the guttering is difficult to access without commissioning professional contractors, (which we cannot currently afford). Professional roofing specialists (from "Roofline Fascias") who specialise in church roofing work, did visit just before "Lockdown" and we may need to revisit how much it would cost to have them properly cleaned before next winter.

On a happier note, I am pleased to report the successful completion of all remedial work to the brackets holding the (incredibly heavy) main bells (mentioned in my last report). Although this was an expensive "fix"

costing £7,000+, it was essential work and we are looking forward to welcoming back Ryan Trout and the Campanologists for some new "gigs". I can also confirm receipt of a cheque for £900 from The Devon Church Bells Restoration Fund, following an inspection of the work carried out by Taylors'. I know Ryan is also actively seeking further financial support to help towards the construction of the planned mezzanine "bell-ringing" floor in the Tower. Ryan and his colleagues have also put in a lot of work clearing and repairing the existing platform in the tower, which has also suffered from the weather, damaging the timber floor between the 5<sup>th</sup> and the Tenor bell which will also probably need replacing at some point in the near future.

Lack of funds is the very simple reason why the plan to build a mezzanine floor in the Tower to give better and safer access for the bell-ringers, together with WC, kitchen facilities and creche area where the current Vestry is situated, has not moved on since my last report. Unfortunately, it is now on semi-permanent hold because we simply cannot afford the works unless we can raise funds from Charities/donations. The Covid-19 pandemic has, of course, effectively precluded most fund-raising activities but with the imminent lifting of all Government imposed restrictions, our principal task in the current year is to raise funds across the board.

One of the most obvious (and pressing) funding requirements is to continue to maintain the churchyard. We have a stark choice to make very soon. There is virtually no money left in the Churchyard Fund and the reality is fast approaching whereby we will have to either leave it to nature or else rob Peter to pay Paul and use money from the General Fund. In common with most churches in the Diocese, Covid-19 restrictions on physical services (which have only recently recommenced), have severely restricted our congregational income. We are again applying to The Parish Council for a donation (which has amounted to £400 per annum over the past few years) to be put towards the cost of cutting the grass in the Churchyard. The Treasurer will outline the current state of the Churchyard Account in her Report but suffice to say that we will not be in a position to continue employing "Clean-Cut" without additional funds/donations.

Again, I would like to put on record the excellent job done by them for a very reasonable price, the cost of which, incidentally, has been frozen for the past four years. We are hoping that the Annual Shaugh Prior Duck Race and Barbeque organised by Sue and Peter Burkill will be held this year which raises sorely needed funds, one of numerus events which were cancelled as a result of lockdown last year.

I would again like to take this opportunity to thank Heather Harvey, "resident" organist at St Edward's for her continued support, and for her "stewardship" of the Church organ which remains in very good condition given its limited use over the past twelve months. We are all looking forward to a full resumption of her playing in the near future as it helps hugely to maintaining continuity and enjoyment of services, especially Morning Prayer.

Thanks also to everyone who has helped with the regular cleaning of the church. It is a big job for a small congregation and I am pleased to report that the church has been regularly cleaned and sanitised according to Government Guidelines, to a high standard.

A deserved mention also for Clifton, who has trimmed hedges and provided his gardening services entirely gratis, helping to maintain the Churchyard in very good order throughout the period under review. As highlighted above, the financing of this external maintenance has only been made possible by the generous donations of several members of the congregation and the continued support of the Parish Council but we are reaching a tipping point.

With regard to ongoing attendance at St Edward's, we did manage to pay our Common Fund in full last year. However, with the current parlous state of the Church finances, this is looking very unlikely for the

current year. In terms of numbers, we are just about "holding our own" in terms of regular attendees, albeit at a very modest level. We have a "hardcore" of around 10 parishioners who attend regularly, bolstered to 15+ on a good Sunday. Following the recommencement of "physical" services", we have been very fortunate to have had Fthr Michael Ellis taking a number of recent Eucharist Services, supplementing Fthr Simon's on alternative Sundays. We have very recently also had the most welcome support of Frank as Reader, to help with Morning Prayer services. Whilst the pandemic has taken its obvious toll on wedding and funeral services, I am pleased to report that we have two weddings scheduled at St Edwards over the next couple of months. We also anticipate that funeral/memorial services will resume post lockdown, and whilst the income they generate is welcome, we are obviously very conscious of the solemnity of these services.

I have informed Father Simon that I am putting myself forward for re-election at the Annual Meeting and I sincerely hope that, if elected, my next report on St Edward's will reflect an improved financial position, strong and secure church fabric, successful fund-raising activities and a thriving congregation. I will be saying my prayers!!

As restrictions are lifted, we look forward to the church fully reopening for existing and new activities, and to welcoming parishioners both old and new. As I'm new to the role of Church Warden I very much appreciate any help, support and advice. Many thanks to Peter, Wendy and Mark who have answered my many questions. I would like to thank Karen Griffiths for her work promoting our Parish online and organising the St Anne's bookings.

Once all covid restrictions are lifted we hope to take forward all that has worked well in the past and strive to find new ways of engaging with the community

## **Mission and Ministry**

Whilst mission is at the heart of the Parish, many aspects have of course been affected by the Covid pandemic. However, whilst in person contact has been very limited, there has of course been online worship. I can see huge opportunities for the church in the future in the online sphere.

There have been no hall bookings at St Anne's Church since March 2020 – thus impacting the Parish's income. I have contacted all previous 'bookers' and we have many who wish to continue. We have unfortunately lost two weekly bookings and the prospect of possibly losing a third. However, I propose an ongoing pro-active marketing drive to advertise the hall hire at St Anne's.

In terms of the Community Market this has also not operated since March 2020. We would hope to restart the market as soon as possible. However, we will need to assess the feasibility whilst social distancing rules apply.

On a very positive note, there have been cooperative moves between the local Glenholt community and St Anne's Church. The Glenholt Community Larder have been operating a free food larder at St Anne's twice a week since 30 January 2021. The larder is offered to all with a PL6 postcode. During the first 3 months, the Larder has provided 6521.84 kg of free food to 1014 households. (For more detailed information on these figures, please see the Glenholt Community Larder Report below)

Additionally, from September this year there will be a monthly Compassionate Café at St Anne's. Ruth and I have undertaken the St Luke's Compassionate Friends course and have been working with the North Plymouth Compassionate Friends Network with a view to hold a Compassionate Café at St Anne's. The area covered by the Network includes the Parish areas of Glenholt, Belliver and Roborough. The Compassionate Cafe has now been confirmed, and whilst this will primarily be intended for those affected by bereavement, we hope to add other aspects such as including those who are isolated and lonely, financial signposting and possibly computer/internet help.

So whilst we cannot avoid the detrimental effects of Covid, we can I believe look forward to an exciting 'new' future in terms of community relations and the opportunities for mission in an online environment.
